| 2. All fish weighed are subject to a freshness test.   | 2018     |
| 3. Any attempt to increase the weight of the fish will result in immediate disqualification.   | \$32,300 |
| 4. All fish are to be weighed at official weigh station at Northside Marina.   | 2017     |
| 5. Fishing hours are from 5:00 a.m. July 12th to 4:00 p.m. July 13th.  | \$31,000 |
| 6. The tournament channel will be 71 VHF.  | 2016     |
| 7. Anglers with fish hooked up, but not boated, by 4:00 p.m. Saturday July 13th must notify Committee Boat.  | \$32,000 |
| 8. Weather committee makes final decision on fishability based upon current conditions & NOAA forecasts.   | 2015     |
| 9. Fishing may be stopped, delayed, or postponed. Please listen for announcements on CH. 71 during high wind conditions.   | \$34,000 |
| 10. Rules committee settles all disputes. Protests must be filed in writing no later than 4:00 p.m. Saturday.  | 2014     |
| 11. Weigh station will be open from 4:00 p.m. to 6:00 p.m. on Friday and 3:00 p.m. to 5:00 p.m. on Saturday.   | \$38,000 |
| 12. All boats must be prepared to weigh their fish no later than 5:00 p.m. Saturday.   | 2013     |
| 13. Fishing is limited to Cape Cod Bay. The demarcation line runs from Race Point to Marshfield. Check your chart.   | \$32,000 |
| 14. Fish weighed must be tagged identifying the angler. <b>No untagged fish will be weighed or entered.</b> Tags are provided in your Captains bag.  | 2012     |
| 15. <b>Boat/Team Prizes are the total weight of 3 fish one of which must be a bluefish.</b>  | \$33,000 |
| 16. All Adult and Family categories have the following prizes categories; 1st place team/boat; 1st & 2nd place Bass—Kids, Women's & Men's. 1st & 2nd place Bluefish—Kids, Women's & Men's.   | 2011     |
| 17. A fish is to be entered in 1 category at weigh-in. Once entered it's category can not be changed. Any fish weighed in the 2nd day may replace and supersede a previously entered fish. Fish weights are not announced.   | \$34,000 |
| 18. <b>Cape Cod Bay Bass &amp; Bluefish Tournament is a recreational tournament abiding by Massachusetts Recreational Saltwater Fishing Rules which require a saltwater license for age 16 and over. This license is obtainable at <a href="http://www.mass.gov/marinefisheries">www.mass.gov/marinefisheries</a> or call 866-703-1925</b> | 2010     |
| 19. Children under 7 years of age are not eligible for prizes. Prizes for ages 7 through 16 will consist of trophies.  | \$32,000 |
| 20. For conservation purposes, a minimum Bass length is 30" with a suggested minimum on Bluefish at 20".   | 2009     |
| 21. Mass saltwater recreation limits one 28" minimum Bass per person per day.  | \$40,000 |
| 22. All fish entered must have weights verified & initialed by Captain or crew rep at time of weigh in.  | 2008     |

In consideration of the acceptance of me and my team and crew entry and for other good and valuable consideration received, we hereby remise, release, and forever discharge the Tournament and its respective heirs, executors, administrators, legal representatives, successors and assigns of and from all claims, suits, obligations, liabilities, losses, damages, costs or expenses which our team or our heirs, executors, administrators, legal representatives, successors and assigns may have against the Tournament, arising out of, resulting from, or in any way connected with my participation in the above described tournament. We understand that this release includes any claims based on any negligent act or negligent omission of the Tournament.
