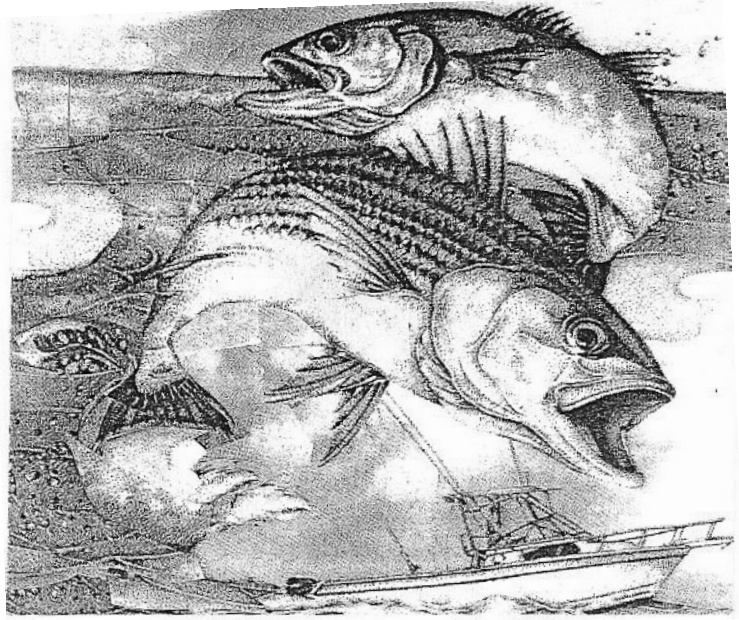

| <ol style="list-style-type: none"> 1. Doing our part to conserve the troubled Striped Bass stock this year's tournament will allow 1 and only 1 Bass to be landed per boat daily. This being more restrictive than the Massachusetts recreational limit of 1 fish per angler per day. In addition we are adhering to the new Slot limit of 28" to 34.99" overall length. We do allow the Massachusetts Bluefish limit of 3 fish per angler, any size daily. 2. 2020 Tackle requirements - No gaffing, netted only allowed for Bass. In-line circle hooks only may be used when baiting fish for striped bass. 3. All fish weighed are subject to a freshness test. 4. Any attempt to increase the weight of the fish will result in immediate disqualification. 5. All fish are to be weighed at official weigh station at Northside Marina. 6. Fishing hours are from 5:00 a.m. August 14th to 4:00 p.m. August 15th. 7. The tournament channel will be 71 VHF. 8. Anglers with fish hooked up, but not boated, by 4:00 p.m. Saturday August 15th must notify Committee Boat. 9. Weather committee makes final decision on fishability based upon current conditions & NOAA forecasts. 10. Fishing may be stopped, delayed, or postponed. Please listen for announcements on CH. 71 during high wind conditions. 11. Rules committee settles all disputes. Protests must be filed in writing no later than 4:00 p.m. Saturday. 12. Weigh station will be open from 4:00 p.m. to 6:00 p.m. on Friday and 3:00 p.m. to 5:00 p.m. on Saturday. 13. All boats must be prepared to weigh their fish no later than 5:00 p.m. Saturday. 14. Fishing is limited to Cape Cod Bay. The demarcation line runs from Race Point to Marshfield. Check your chart. 15. Fish weighed must be tagged identifying the angler. No untagged fish will be weighed or entered. Tags are provided in your Captains bag. 16. Boat/Team Prizes are the total weight of 3 fish one of which must be a bluefish. 17. All Adult and Family categories have the following prizes categories; 1st place team/boat; 1st & 2nd place Bass—Women's, Men's & (Kids-family). 1st & 2nd place Bluefish—Women's, Men's and (Kid's-family). 18. For 2020 all entered fish, both on Friday & Saturday, are to be placed in a category, verified and initialed by the Captain or crew representative during the Saturday weigh in period. Fish weights are not announced. 19. Cape Cod Bay Bass & Bluefish Tournament is a recreational tournament abiding by Massachusetts Recreational Saltwater Fishing Rules which require a saltwater license for age 16 and over. In consideration of the acceptance of me and my team and crew entry and for other good and valuable consideration received, we hereby remise, release, and forever discharge the Tournament and its respective heirs, executors, administrators, legal representatives, successors and assigns of and from all claims, suits, obligations, liabilities, losses, damages, costs or expenses which our team or our heirs, executors, administrators, legal representatives, successors and assigns may have against the Tournament, arising out of, resulting from, or in any way connected with my participation in the above described tournament. We understand that this release includes any claims based on any negligent act or negligent omission of the Tournament.
